Library:

Circulation for September 1619. Patron count was 2066. We had 221 uses of the computers. We had 19 new library cards. 81 people attend library programs.

Tech nights were held on September 4, 11, 18, 25

Story times were held September 6, 20, 27

We had a stuffed animal sleepover the evening of the 17th. Kids were encouraged to come in PJs for bedtime stories and leave their stuffed animal to spend the night in the library. Katryna had pictures, which we posted on Face Book, showing what the animals did after everyone left the library.

Sept 3rd K-20 (our Internet provider) installed an up graded router for our system.

Sept. 11^{th} Katryna and I manned a booth at the school open house. We had 10 people sign up for library cards.

Sept 13th we closed the library for the morning so we could get training from the State Library on our VR headsets. We will be setting up opportunities to use them.
